Terms & Conditions

- 1. The envelop of the bid form should be addressed to Chief Executive Officer, Bhutan Telecom Limited, Thimphu and the bid form should be submitted in a sealed envelope.
- 2. The bidders have to deposit an earnest money of Nu. 25,000.00 for each vehicle in the form of demand draft or cash warrant addressed to Chief Executive Officer, Bhutan Telecom Limited, Thimphu along with the bid form. Earnest money can also be in cash.
- The earnest money of the successful bidders will be retained until the successful bidder deposits the full bid amount. The earnest money of the successful bidder will be returned upon depositing the full bid amount.
- 4. The earnest money of unsuccessful bidders will be refunded immediately after the decision is made by the departmental tender committee to sell the vehicle at the quoted price or not.
- 5. The successful bidders have to deposit 100% of the successful bid amount within 7 (seven) working days from the date of the bid opening.
- The earnest money of unsuccessful bidders will be refunded immediately after the decision is made by the departmental tender committee to sell the vehicle at the quoted price or not.
- 7. The earnest money of the successful bidder will be forfeited if the successful bidder does not deposit the 100% bid amount within 7 working days and the bid will no longer be valid.
- 8. The departmental tender committee reserves the right to accept or reject the bids without assigning any reason whatsoever. In case of misunderstanding controversy or dispute with regard to the sealed bids, the committee's decision will be final and binding.
- 9. Bhutan Telecom Limited will be auctioning off the vehicles on "As Is Where Is" basis through a sealed bid.
