### **Terms & Conditions**

1. The envelop of the bid form should be addressed to Chief Executive Officer, Bhutan Telecom Limited, Thimphu and the bid form should be submitted in a sealed envelope.
2. Each bidder will have to deposit an earnest money of Nu. 25,000.00 (Nu. Twenty-Five Thousand) only for each vehicle (in Cash/Demand Draft addressed to Chief Executive Officer, Bhutan Telecom Limited, Thimphu) along with the bid form.
3. The earnest money of the successful bidders will be retained until the bidder deposits the full bid amount. The earnest money of the successful bidder will be returned upon depositing the full bid amount or can be adjusted against their bid amount.
4. The successful bidders will have to deposit 100% of the bid amount within 7 (seven) working days from the day departmental tender committee accepted the bid and take the delivery of the vehicle at their own cost. Failure to do so will result in the forfeiture of the earnest money and the bid will no longer be valid.
5. Ownership should be changed by the successful bidders after taking the delivery of the vehicles within 15 days and any tax levied for the vehicles sold through auction needs to be borne by the respective successful bidders.
6. The earnest money of unsuccessful bidders will be refunded immediately after completion of the auction.
7. The departmental tender committee reserves the right to accept or reject the bids without assigning any reason whatsoever. In case of misunderstanding controversy or dispute with regard to the sealed bids, the committee's decision will be final and binding.
8. Bhutan Telecom Limited will be auctioning off the vehicles on "As Is Where Is" basis through a sealed bid.
9. The vehicles may be inspected at Bhutan Telecom Limited, Corporate Headquarter, Thimphu during office hours. It will be assumed that interested parties bidding for the vehicle have inspected the vehicle prior to the auction. No compliant will be entertained later.
